BusyBox is a multi-call binary that combines many common Unix utilities into a single executable. Most people will create a link to busybox for each function they wish to use and BusyBox will act like whatever it was invoked as.

BusyBox is copyrighted by many authors between 1998-2012.

BusyBox is distributed under version 2 of the General Public License (included in its entirety, below). Version 2 is the only version of this license which this version of BusyBox (or modified versions derived from this one) may be distributed under.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. Glibc 2.6.1.1

this directory contains the version 2.6.1 release of the GNU C Library.

The GNU C Library is the standard system C library for all GNU systems, and is an important part of what makes up a GNU system. It provides the system API for all programs written in C and C-compatible languages such as C++ and Objective C; the runtime facilities of other programming languages use the C library to access the underlying operating system.

When it is in working condition, we will make it available alongside future glibc releases. LinuxThreads will not be supported.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.
